Annual Membership FAQ's and Timeline

What is the Annual membership?

It is designed to help make the enrollment process as quick and easy as possible for our dance families! In the past, classes have filled up quickly when registration opened, some as quickly as 2 hours after registration begins!

Also, having the knowledge of which dancers are wishing to continue with their training helps us to accommodate enough space in the levels for all of our dancers. Last year we placed Musical Theatre after Hip Hop since many dancers were in both. We would not have thought to do that if not for this process!

Extra bonus: we enroll your dancer(s) for you! This way you don't have to worry or stress about getting into the class(es) recommended for you and/or your dancer.

How do I benefit from this?

This process will make sure that your dancer has a guaranteed spot in the level he or she has been recommended for. This makes for a stress free enrollment season! Members can also receive discounts when booking birthday parties and summer camps.

Sounds awesome! What do I need to do now?

Step 1.

A-If you are continuing- The annual membership fee will be posted on March 15th and is due on March 25th.

B- If you are opting out- Simply take 1 minute to fill out the Google Form sent through email before March 15th to let us know you or your dancer will not be continuing with dance training for the 2020-2021 dance year.

Step 2.

A- If you are continuing- Once the recommendations are sent out on April 1st, you will need to fill out a Google form to let us know if you wish to add/switch styles from what you currently take. If the class you have been recommended for has options fo multiple days, we will be sending a third and final form to let us know which class day you prefer.

B- If you are opting out- Once you fill out the first Google Form, we will add you to the opt out list and nothing further needs to be one

Step 3.

A. If you are continuing- After you have filled out the Google Form, we enroll you or your dancer into the class(es) you requested. You'll just need to double check the enrollment in your account after we have posted it. The first month tuition deposit is then due June 25th after all enrollments have been finalized. (see timeline below)

B- If you have opted out, and changed your mind, please let us know so we can get you or your dancer enrolled in the correct class! You may re-enroll at the current price at anytime before April 10th.

When will the schedule be released?

Once we have student counts from our Membership renewals and all Google Forms for classes filled out, we will begin the process of planning the schedule out. We expect to release the 2020-2021 schedule mid to late May.

My dancer wants to continue but we are unsure of our fall schedule. What should we do?

We love it when kids are well rounded and try out other activities! We understand that planning schedules can be hectic and stressful.

There are two options here-

1. Re-enroll now and switch classes later if needed.

We are typically able to find a class that will fit with the dancer's schedule if you need to switch for any reason. We try as best as we can to work around your busy schedules!

2. Opt out now and wait until your schedule is set to re-enroll at a later date.

You may renew your membership at anytime you know what your schedule will look like. However, we cannot guarantee there will be an opening in the style and level of your choice for those renewing after April 1st.

I don't think dance will work out for us next year. What do I need to do to opt out?

Please fill out the Google Form emailed to you by March 15th to opt out and avoid paying the Annual Membership fee.

I'm ready to re-enroll! What is the timeline for the Enrollment process?

- **1.** Annual Membership fee- due March 25th- \$45 per dancer or \$80 per family. (\$55 and \$90 if paid after 4/1)
- 2. **Recommendations- released April 1st:** You will receive individual recommendations through your portal. From there, you have 10 days to make any changes or schedule an appointment with the director if you have any questions/concerns about placement.
- 3. Google Form for adding/switching classes- due April 10th: If you're looking to switch/ drop/add, please let us know by 4/10. This way we can use that information to create a schedule that can accommodate all our dancer's interests. This will also ensure that there will be an opening in the style and level recommended to your dancer.
- 4. 2020-2021 Schedule released- Mid-Late May: Our schedule will be released around the middle of May. The schedule is set at this time, but it is subject to changes until August, depending on enrollment interest. You will have at least 1 week to make any changes to your schedule once it is released.
- 5. Your finalized schedule- May 31st: At this time your schedule should be set. Any changes you want to make your dancer's schedule should have been addressed with the office by now.
- **6. Schedules sent out- June 15th:** You will be enrolled in all your classes. We will send each dancer/family their fall schedules- kind of like school! Tuition will be posted then as well. Please take the time to review your schedule before your tuition deposit is due on 6/25.
- 7. Tuition deposit is due June 25th- 1st-month tuition deposit is required at the time registration is complete to ensure that all students have a guaranteed spot in the class he or she has been recommended for and to be sure classes have the necessary enrollment to run. Cash or check payments should be made before this date in order to avoid a late fee. If you would like to take advantage of the pay-in-full 5% discount you must pay by check or cash before 6/25.
